#### 3. BUILDING WARRANTS

The Committee noted that, during the period 17 November 2014 to 12 December 2014, a total of 68 Building Warrants, 3 Demolition Warrants and 17 Amendments to Warrant had been approved with an estimated cost of £7,345,305.

# **PLANNING APPLICATIONS**

### 6. FONTSTANE HOUSE, 9 ALBERT STREET, MONIFIETH

There was submitted Report No 8/15 by the Head of Planning and Place detailing Application No 14/00896/PPPL, for planning permission in principle for the erection of a dwellinghouse for Mr and Mrs Philip and Shona Leckie, at Fontstane House, 9 Albert Street, Monifieth. The application was recommended for conditional approval.

The Committee agreed that the application be approved for the reasons, and subject to the conditions, given in Section 10 of the Report.

### 7. 9 CASTLE STREET, FORFAR

There was submitted Report No 9/15 by the Head of Planning and Place detailing Application No 14/00878/FULL for the change of use and external alterations of office to form six flats and retention of office to rear of the first floor for Caledonia Property Company Ltd at 9 Castle Street, Forfar. The application was recommended for conditional approval.

# 8. LISTED BUILDING CONSENT APPLICATION - 9 CASTLE STREET, FORFAR

There was submitted Report No 10/15 by the Head of Planning and Place detailing listed building consent Application No 14/00879/LBC for the internal and external alterations to form 6 flats and retention of the office at the rear of the first floor for Caledonia Property Company Ltd at 9 Castle Street, Forfar. The application was recommended for conditional approval.

Having previously viewed the slides, the Committee agreed that the listed building consent application be approved subject to the conditions detailed at Section 10 of the Report.
