- This Order may be cited as the "Angus Council (Shanwell Road & Balmachie Road, Carnoustie)(Redetermination of Means of Public Right of Passage from Footway to Cycletrack) Order 201X" and shall come into operation on the day of Two thousand and nineteen.
- 2. The footways, specified in the Schedule to this Order, indicated by sawtooth hatching on the plan referred to in the said Schedule shall become cycletracks, the right of passage being exercisable on foot and pedal cycle only.

FOOTWAY OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED

- That section of footway lying on the south side of Shanwell Road Carnoustie extending from its junction with the west footway of Balmachie Road westwards to the cycletrack on the east side of the main access to Carnoustie High School, a distance of 120 metres or thereby.
- That section of footway lying on the west side of Balmachie Road Carnoustie extending from its junction with the south footway of Shanwell Road southwards for a distance of 15 metres or thereby.

All of which footways are shown sawtooth hatched on the plan accompanying this Order.
