INVERESK COMMUNITY COUNCIL Minutes of meeting held on Monday 18th March 2024 at Inglis Hall, Edzell

Planning and CNP Report

Kate Skene was not at the meeting but had sent correspondence that there were no new applications for the ICC area.

There had been a planning meeting held by Angus Council regarding the proposed shed build at Little Brechin – the shed has now been given planning approval. There has been a request to release the e-mail communication which attributed to the comment submitted by ICC on this application. It has been agreed by the ICC members not to release the e-mail communication at this time. Claire will contact the requester to let them know of the outcome.

Treasurer's Report

Alan was not at the meeting to provide an update.

Police Report

The Police Report had been distributed to all the Community Council members before the meeting. The Police Scotland Representative read out the report to the meeting which included the local crime figures.

He encouraged residents to join the local Neighbourhood Watch groups and also to complete the Your Police survey on the Police Scotland website. He also invited the public to attend an event being held at The Cottage, Edzell on Wednesday 3rd April 1000-1200hrs where the Police and Fire Service will be in attendance.

SSEN Transmission East Coast

This issue is ongoing.

Gus has been at several well attended meetings regarding this proposal (latest one being held in Forfar) which showed there was lots of opposition to the proposal.

Gus has also spoken to MP Dave Dougan who asked Gus to ensure that anyone who submitted objections to the proposal ensured they submitted a good reason for their objection.

Gus has asked Dave Dougan to speak to ESO regarding the proposal and to get the design revisited whilst also asking for the costing of the proposal to be updated.

There was a discussion regarding sub-sea cables and energy islands where it was suggested that decommissioned oil rigs were used although it is thought that if the rigs are decommissioned it is due to them no longer being fit for purpose/end of life and therefore not suitable to be used as "islands" also the depth of the UK seas may mean it is not possible to have energy islands.

Recurring items

Edzell Muir

No update as Cllr Beattie was not at the meeting. Gus will ask him for an update regarding the survey of the Muir.

Edzell Muir Playpark

Claire has had a reply from the Council regarding the playpark having barriers erected round it. This is due to the bark chippings being washed away in the last floods. The Council hope to re-lay bark chips in the next few weeks depending on the weather.

Resilience

Lethnot Resilience Hub has its equipment and volunteers in place.

Little Brechin – temporary accommodation is available at a private residence at the moment. Unfortunately, Dick informed the meeting that the more permanent planned location for the hub was no longer available due to a change of ownership.

Inchbare – The hall is setting up a new management structure and it is thought that the planning for the resilience hub will be postponed until this is in place. Edzell – No update.

Whishop Burn Bridge

This has been delayed due to the weather and Balfour Beatty are awaiting contact from the Church to proceed. Judith will contact Balfour Beatty for an update.

Shaking Bridge, Edzell

It is thought that the bridge is still closed. No update from Aberdeenshire Council.

Proposed Crossing of Edzell High Street

Kate has composed a survey to put on the Edzell Facebook page, but it is thought this has not been made live yet.

Little Brechin

Speeding Traffic

The signs have now been erected. The road is in a poor state of repair with potholes. Dick to report to the AccessLine.

Inchbare

An Active Travel submission has been made to improve/create pathways around Inchbare. Claire has submitted a comment that a continuation of the path from the Edzell straight to Westside and on to Inchbare would be helpful (ICC had already submitted this request to Angus Council several years ago).

Glenesk

Ken was not at the meeting but sent a report via e-mail.

Some of the potholes on the glen road have been repaired.

There have been sheep roaming on the road and Ken will speak to the Estates regarding this issue.

EE phone signal is up and running to their customers only at the moment.

Ward Councillors' Report

No Councillor's attended the meeting to provide an update.

Brechin Healthcare Group

The BHG are still in negotiations with Angus Council for new premises.

Correspondence

Bi-annual meeting of Community Councils with Angus Council

Floodmobile

Cones on Dunlappie Road, Edzell

A member of the public expressed concern re: traffic cones in place at the top of a blind crest on Dunlappie Road, Edzell. This is causing pedestrians to walk far out in the road at the blind crest. It is unknown why the cones are in place as no work is currently being undertaken in the area. The member of the public has already contact the AccessLine but has had no reply. Claire will submit an enquiry online also.
