UK Parliamentary election for the Angus & Perthshire Glens and Arbroath & Broughty Ferry constituencies

1. An Election is to be held for a Member of Parliament to serve the following constituencies:
 - Angus & Perthshire Glens; and
 - Arbroath & Broughty Ferry
2. Nomination papers can be obtained from the offices of the Returning Officer, Election Office, Digital Reprographics Unit, Sylvie Way, Orchardbank Business Park, Forfar, DD8 1AY, during the times stated below.
3. Nomination papers must be delivered to the Returning Officer at Election Office, Digital Reprographics Unit, Sylvie Way, Orchardbank Business Park, Forfar, DD8 1AY **by prior appointment**, on any day after the date of this notice, Monday to Friday 10am to 4pm (excluding bank holidays) but no later than **4pm on Friday 7 June 2024**.
4. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as banker in the United Kingdom. Deposits may also be made by bank transfer to the following account:

7. New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote arrangements must reach the relevant Electoral Registration Officer by **5pm on Wednesday 19 June 2024**. Applications can be made online: <https://www.gov.uk/apply-postal-vote>.

8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the relevant Electoral Registration Officer by **5pm on Wednesday 26 June 2024**. Applications can be made online: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>.
9. New applications to vote by proxy at this election must reach the relevant Electoral Registration Officer by **5pm on Wednesday 26 June 2024**. Some applications can be made online: <https://www.gov.uk/apply-proxy-vote> .
10. Applications to vote by emergency proxy at this election must reach the relevant Electoral Registration Officer by **5 p.m. on Thursday 4 July 2024**.
