**ROADS (SCOTLAND) ACT 1984**

**ANGUS COUNCIL (FORMER A92 ARBROATH – MONTROSE ROAD AT COURTHILL,  
INVERKEILOR) (STOPPING UP) ORDER 2024**

Angus Council, in exercise of the powers conferred on them by Section 68(1) of the Roads (Scotland) Act 1984 and of all other powers enabling them in that behalf, and having considered that the road specified in the Schedule to this order has become unnecessary and being satisfied that a suitable alternative road is not necessary, hereby make the following order: –

1. This Order may be cited as the Angus Council (Former A92 Arbroath – Montrose Road at Courthill, Inverkeilor) (Stopping Up) Order 2024 and shall come into operation on 27 May 2024.
2. The stopping up of the road in the County of Angus specified in Part I of the Schedule to this order is hereby ordered, subject to reservation of a means of passage for non-motorised users of the road specified in that part of the Schedule.
3. Where there is, immediately before the date on which the said road is stopped up under this order, any apparatus belonging to any statutory undertakers under, in, on, over, along or across that road for the purpose of carrying on their undertaking, the said statutory undertakers shall after the commencement of this order continue to have all rights in respect of the said apparatus as they had immediately before that date.

**PART I**

**ROAD TO BE STOPPED UP**

That section of the former A92 Arbroath – Montrose (Hawkhill Road) from a point 411 metres or thereby south-west of its junction with Hawkhill Road (north branch), extending south-westwards for a distance of 70 metres or thereby (marked A – B – C – D), all as shown zebra hatched on Drawing Number RSA/SU/22/HRI/1 accompanying this order.

A means of passage is reserved for non-motorised users of the above-mentioned road.
