Councillors Update.

Coucillor Scott said that maaping and modeling was taking place with the housing stock involved in the floods last October, This process will take at least six months to complete. Tenants in the flats above the affected housing are reporting hearing bits of masonry falling. The path at Skinners Burn has been reopened and work on the flooding in the Den has started. Wards Park has been taken over by the Brechin City Community Trust on a 15 year lease . It remains open to the Public She proposed that attemps be made to regenerate the BMX track was although still popular with local youngsters had fallen into a state of neglect. The Community Council would support this project.
