EXCEPTION TO CINEMA LICENCE CONDITIONS

REPORT BY THE DIRECTOR OF LEGAL, GOVERNANCE AND CHANGE

1. ABSTRACT

The purpose of this report is to consider the request from The Montrose Playhouse Project Limited (Licence Number CL 6) to permit the exhibition of seventeen (17) unclassified films as detailed in **APPENDIX 1 AND 2**.

2. ALIGNMENT TO COUNCIL PLAN AND COUNCIL POLICIES

3. RECOMMENDATIONS

It is recommended that the relevant members of the Committee:-

- (i) determine whether to permit the exhibition of seventeen (17) unclassified films; and
- (ii) if the Committee is minded to permit the showing of the seventeen (17) unclassified films, determine what, if any, conditions apply to the permission.

4. BACKGROUND

Condition 3 of Cinema Licence number CL 6 granted to The Montrose Playhouse Project Limited under the Cinemas Act 1985 requires that:-

- 3. No film shall be exhibited unless
 - a. It has received a 'U', 'PG', '12', '15' or '18' certificate of the British Board of Classification; or
 - b. It is a current newsreel which has not been submitted to the British Board of Film Classification.

Condition 7 states:

7. Notwithstanding the conditions herein before contained, a film may be exhibited, or persons or any class of persons, may be admitted thereto if the permission of the licensing authority is first obtained and any condition of such permission is complied with.

In an email dated 5 August 2024 from the licence holder an application for permission to exhibit seventeen (17) unclassified films was received as they had not received a certificate from the British Board of Film Classification. The BBFC considers a wide number of factors when considering what age rating a film should receive — a copy of their guidance is set out in **APPENDIX 3**.

Members of the Committee agreed to split the films into two groups, as noted in **Appendices 1 and 2**, and the members of each respective group have had the opportunity to view the films.

It is recommended that the Committee determine whether to permit the exhibition of the seventeen (17) unclassified films; and if the Committee is minded to permit the showing of the seventeen unclassified films, determine what, if any, conditions apply to the permission.

5. FINANCIAL IMPLICATIONS

There will be no financial implications arising directly from this report.

6. RISK MANAGEMENT
