1. APOLOGIES

2. DECLARATIONS OF INTEREST AND STATEMENTS OF TRANSPARENCY

Councillor Durno made a Statement of Transparency in relation to Item 4, Report No 209/24, in that she had worked with the applicant in the past.

3. NEW APPLICATION - RESIDENTIAL CARAVAN SITE - BARRY DOWNS RESIDENTIAL CARAVAN PARK, BARRY

There was submitted Report No 208/24 by the Director of Legal, Governance and Change presenting a new application for a Residential Caravan Site licence in relation to Barry Downs Residential Caravan Park, Barry, under the Caravan Sites and Control of Development Act 1960 which required to be determined by the Committee, and as detailed in the Appendix to the Report.

The Committee agreed to grant the application subject to the Model Standards for Residential Mobile Home Site Licences produced by the Scottish Government.

4. RENEWAL APPLICATION – RESIDENTIAL CARAVAN SITE – MONARCH OF THE GLEN RESIDENTIAL CARAVAN PARK, BRECHIN ROAD, MONTROSE

There was submitted Report No 209/24 by the Director of Legal, Governance and Change presenting a renewal application for a Residential Caravan Site licence in relation to Monarch of the Glen Residential Caravan Park, Brechin Road, Montrose, under the Caravan Sites and Control of Development Act 1960 which required to be determined by the Committee, and as detailed in the Appendix to the Report.

The Committee agreed to grant the application subject to the Model Standards for Residential Mobile Home Site Licences produced by the Scottish Government.

(a) Street Trader's Licence (Fixed Pitch)

The Committee considered an objection in relation to an application for a Street Trader Licence (fixed Pitch) received on 18 June 2024 from Margaret Anderson for a fixed pitch at Baden Powell Road, Arbroath selling hot and cold food and drinks on Monday to Friday between 8am to 3pm.

Mrs Anderson, the applicant, was present and addressed the Committee and answered members questions. The objector was not present.

The Committee agreed that the application for a Street Traders licence be granted subject to the standard conditions.
