## COMMUNICATION AND ENGAGEMENT UPDATE

## REPORT BY JILLIAN GALLOWAY, CHIEF OFFICER

## 1 ABSTRACT

This report provides the Integration Joint Board (IJB) with an update relating to progress to deliver the commitments aligned to the Communication and Engagement Strategic Framework 2023-2026.

## 2 ALIGNMENT TO THE STRATEGIC PLAN

This report aligns to the following strategic priorities in the Angus IJB Strategic Commissioning Plan

- Priority 1 Prevention and Proactive Care
- Priority 2 Care Closer to Home
- Priority 3 Mental Health & Wellbeing and Substance Use Recovery

Communication and Engagement is also a strategic enabler within AIJB Strategic Commissioning Plan.

## 4 BACKGROUND

Angus IJB has a legal requirement (Section 36 of the Public Bodies (Joint Working) (Scotland) Act 2024) to involve staff, patients/service users and all stakeholders as we continue to develop effective, robust and sustainable health and social care services for the people of Angus. The Communications and Engagement Strategic Framework 2023-2026 was approved by AIJB in October 2023 (IJB 74/23). The Framework demonstrates Angus Health and Social Care Partnership's (AHSCP's) commitment to engage, listen to and respond to everyone who is involved with health and social care services. AHSCP aim is to continue to increase our communication and engagement activity and strengthen our messaging to support greater understanding and awareness of health and social care services.

AHSCP continues to work closely with Angus Council and NHS Tayside Communication Teams and Healthcare Improvement Scotland's Community Engagement Team. AHSCP also work closely with Community Planning Partners and Voluntary Action Angus to maximise communication and engagement opportunities to enable a place-based and whole family approach to improving health and wellbeing outcomes in Angus.

Since September 2023, authors of each IJB report have provided an update, where relevant, regarding engagement activities specific to each report. This has resulted in IJB members being informed and assured regarding communication and engagement activities in a timely manner to inform decision making.

In May 2024, the Scottish Government and the Convention of Scottish Local Authorities (COSLA) updated their guidance called <u>'Planning with People'</u> which sets out the responsibilities for NHS Boards, Local Authorities and Integration Joint Boards have to community engagement. Planning with People applies to all care services and promotes working with people as equal partners whilst embedding consistency, culture change and collaboration. The latest changes include the inclusion of flowcharts to provide greater clarity on relevant processes to follow in relation to service change ensuring proportionate public engagement meaningfully informed planned local service change.

#### 5 CURRENT POSITION

An efficient and effective communications and engagement function is viewed as an essential enabler to the delivery of AIJB's Strategic Commissioning Plan. The involvement and participation of all stakeholders continues to be important in shaping how AHSCP plan, design, deliver and evaluate local health and social care services, making sure that stakeholders are central to decision-making processes.

A full summary of the Communication and Engagement Strategic Framework actions can be found in Appendix 1.

**Digital and Marketing Group**. This group brings together representation from all online platforms and printed marketing and aims to provide a standardised approach across all online and printed communications with the public, staff and partner organisations. The Group is taking forward several actions which contribute to effective communication and engagement.

The AHSCP **Facebook**, **Instagram and X** (previously Twitter) continue to provide regular updates on a wide range of topics. Work remains ongoing to increase the number of followers.

**AHSCP website.** Work is ongoing to continue to improve the layout and content of the website with the aim to attract more visitors. From October 2023 – September 2024 there were 40,840 visits from 13,150 users which is a 2% increase compared to last year.

**Health Promotion**. AHSCP continue to encourage appropriate health promotion behaviour, and support local and national information and awareness campaigns on social media platforms.

**Media Relations.** AHSCP continue to welcome members of the media to IJB meetings and respond to media enquiries in a timely manner and employ proactive media engagement as often as possible. In May 2024 AHSCP featured on STV news promoting the launch of Angus

'Are you OK' campaign and in September 2024, STV approached AHSCP to contribute to a news feature focusing on the increase in the number of young carers in Angus.

**Podcasts.** Since October 2023 AHSCP have prepared and launched thirteen podcasts. The topics and number of listeners is detailed in Appendix 2. The podcasts provide an additional means in which staff and the public can stay informed about the work of AHSCP.

**Care Opinion.** A trial of Care Opinion was commenced in Angus in 2020 and since April 2023, all services have been added to the service tree. They are now all able to receive feedback through Care Opinion. AHSCP have received a total of 397 stories that have been read 48,121 times. This number includes 123 stories from April 2024 – September 2024 which is an increase of 50% on the same reported period last year. 90% of the stories have been positive. The number of services becoming aware of the benefits of using Care Opinion and actively promoting Care Opinion continues to increase.

Appendix 3 contains information about the number of stories attributed to active services for October 2023 – September 2024. (It should be noted that sometimes a story will provide feedback on more than one service and a word cloud which illustrates the words used most frequently in feedback received.)

**Events.** Representatives from AHSCP have supported a range of local, regional and national events. This includes:

- Career promotion events with primary and secondary schools. In addition, AHSCP have attended events at Dundee and Angus College and University of Dundee to promote care as a career. AHSCP also attend the Department of Work and Pension/Job Centre events. In May and June 2024, there were targeted recruitment events, in collaboration with providers, in each of the towns in the North of Angus. These are to replicated in the South of Angus.
- Sharing the progress of the Angus Prevention and Proactive Care Programme Steering Group at the Tayside Realistic Medicine Conference on 1 December 2023 and at the National Realistic Medicine Conference on 22 April 2024.

**Lifestyle management Courses**. AHSCP have been working with The Thistle Foundation to deliver Lifestyle Management Courses which are designed to help support people with long-term conditions to build their own coping and recovery strategies and enable them to set up and co-deliver programmes in their own community. Since January 2024 three classes have been delivered with another one planned for October 2024.

**External Reports.** A range of externally written reports are available to IJB members and IJB Audit Committee members via Microsoft Teams. Appendix 4 lists the nine reports that have been shared since October 2023.

**Service User Networks.** AHSCP aim to enable Angus citizens and local third and independent sector organisations to have a direct route of communication and engagement in relation to integrated community health and social care services. The Service User Network met in December 2023 and another meeting will be arranged for December 2024. Further work is required to increase representation from all service users. AHSCP continues to work closely with Angus Carers Centre Carer, Influencer Group and Angus Voice who represent the views and experiences of people in Angus who have mental health problems.

There continues to be a small budget aligned to deliver communication and engagement activity on an annual basis.


