- **1. Welcome and Apologies** EF welcomed everyone, and apologies noted from James Gray-Cheape, Marley Hunter, Angela Gillies, Kathryn Patullo Robin Wardhaugh and Ian Dickson.
- **2. Minutes from previous Meeting:** Notes of previous meeting noted and approved by EF and seconded by DG.
- **3. Matters Arising from previous** A MOWG group has been set up to look at setting up a new housing committee with Cllrs Wann, Braes, Scott, Bell, Devine and Whiteside on it. The bus forum is being looked at by community council, Cllr Clark said she is joining the Tactran meetings soon and will be raising the bus issues. A decent bus service is needed for the public if people are to stop using cars. GC said a bus forum is vital and a good idea, will need to gather views from the public and meet with the council and bus companies. EF said there are issues with bus timetables. JG said on a daily basis buses are missing or run very late. There are issues with the bus station in Dundee at night as it closes and is not a great area for vulnerable people to wait for buses. A lot of the elderly and the young rely on a good bus service. GC raised concerns about potential cuts to services at Whitehills hospital and equipment such as the Xray machine. Secretary to write a letter to NHS asking for information on the Xray machine etc.
- **4. Chairperson's Report**: Stand in Chair Eleanor Feltham see appendix A.
- **5. Secretary Correspondence/Report.** A site visit with PC Anderson took place on where to locate pop up Pete's to help with speeding issues.
- **6. Treasurer's Report:** Nothing to report.
- 7. Police & Fire Service Report: Chair welcomed PC Jenna Conboy to her first community council meeting as community police officer for Forfar. PC Conboy is from Forfar and is looking forward to her role as community officer. She talked about rural crime and the fact that it has gone down at the moment. She also mentioned the issue with shoplifting in the town, the police are arresting them, but they are then on bail awaiting court so repeat offending can occur. Cllr Clark how people can help change how the Police is run. They have been a few teething issues with the move to Angus house to do with IT, hopefully these issues will be resolved. A discussion on law and order took place about how the public can help by reporting crime and coming forward to give statements.

- **8. Local Councillor Update:** Community council congratulated Cllr Clark on being made Provost of Angus. Cllr Clark spoke about British citizenships and how the people involved were proud and happy to be made British citizens. She said it is important to shout to volunteers locally and is looking at a volunteer civic award. **Cllr Greig** mentioned the new blue bins and changes to the timings for collections of the bins and that glass recycling was now separate and that bins for glass were to be put in certain locations for people to put the glass in. This will help with reaching recycling targets and hopefully save the council money. It

was mentioned about the upcoming "keep warm surgery" being led by Dave Doogan MP for Angus on 15<sup>th</sup> November at East and old church.
