1. Welcome, housekeeping, attendance and apologies.

2. Approval of previous minutes.

3. Matters arising from previous minutes.

Request for dog waste bins awaiting update from Angus Council

Standing orders approval SL is on annual leave RB will follow up on her return and will update the community council on the outcome via email.

ID advised there is a Community Resilience Flood Planning meeting open to all 27th October 2024. ID will circulate the information.

4. Police report.

No report available. FC raised question regards the recent traffic collision fatality, if it had been related to local residents' previous concerns over the national speed limit on these roads. RB advised with the limited information available it was not currently being linked to the concerns previously raised.

Report supplied post meeting added to minute for information.

5. Secretary's report and correspondence.

Verbal update: The main theme of communications relate to the ongoing SSEN consultations for the East Coast 400kV Phase 2. There were meetings at the end of September in Forfar and Brechin to update on planned positions of the new pylons. This remains a controversial issue.

Verbal update: KT advised she still doesn't have access to the community council bank account. Previous post holder has advised it is a work in progress to transfer the account access. Reimbursement to KT for the hall booking fees for Farnell meeting on 1st August 2024 remain outstanding. RB advised LB still has access if required. KT advised happy to wait until access resolved.

No concerns raised on either application.

BSR - Craigo Glenskinno Solar Farm. Planners have offered to meet with representatives of A&D CC to discuss any potential impacts for district. ID and FC will attend.

SSEN Request for Scoping Opinion for Proposed Section 37 Application for Kintore to Tealing 400kV overhead line.

Key headings as per full report appendix one. FC noted food security should be considered as the plans affect prime agricultural land. ID noted risk of land cross contamination with organisms such as potato blight. ID preparing a draft response for comment noting short time line as responses required by 9th October 2024.

8. Continuing Matters

Farnell defib – DB - local resident suggested the ideal spot would be the village hall she has agreed to raise at the next village hall committee meeting.

The Farnell Pictish Stone: Costings and details are being sought for housing to protect the stone. Norman Atkinson former Director Museum Services Angus Council .is a good source for guidance and support. ID agreed to supply information on grant support and other possible sources for Farnell to take this forward. Costs to move the stone have been in the region of £7000. RB suggested once location established possibly approach 45 Commando or 212 Royal Artillery reserves both I based in Arbroath as they may be willing to assist as a support to the community Historic Scotland may help with building footing on which to base stone and information boards.

9. AOCB

Mairi Gougeon MSP for Angus North and Mearns (Constituency) will be providing an MSP surgery in Aberlemno Village Hall on Mon 7th October between 12 & 1pm.

Repairs at the entrance to Aberlemno Village Hall car park have been undertaken by Tayside Contracts

As part of the changes to Angus Council waste collections they have suggested a glass recycling point be placed in the car park at Aberlemno Village Hall . Representatives of the village hall committee are meeting with the council to discuss this proposal.

Farnell residents have not had communications regards any similar proposals for Farnell area. DB will follow this up.

FC noted that Angus Council environmental officers were posting labels on bins in the area. Labels state no food waste to be placed in the purple general waste bins. The rural properties out of the main village do not have a food waste collection. KT advised it is possible to get a 150 litre brown bin which could be shared with group

of properties but this would have to be put out to main road for collection as will not collect from private roads.

RB recommended viewing the council meetings online. He expressed concerns at what he considered money wastage at a time when councils are stretched. He gave the example of £17,000 per school to install safe spaces area in every school for a trial period and then £9000 to remove at end trial. JS advised this had been funded from a Scottish Government initiative grants and not local council. JS encouraged others to view the council meetings and suggested doing a web search for "angus council forthcoming meetings "for links to watch live or watch as available on you tube post meeting.

Farnell residents noted there will be a Harvest thanksgiving service 20th October 2024 at Farnell Church to thank farmers. Leaflets are available with more information. KT to post information online.

RB stated he had joined to help get the A&DCC established when there was low level of volunteers and there was a risk of the community council being disbanded. He feels his role is now complete. he will continue to complete current actions but as he now believes his role is complete he asked the meeting to accept this as his formal notice of resignation.

Thanks from the group to RB for the work he has done and best wishes for whatever his plans are going forward

10. Date of next Meeting.

It was agreed that holding this meeting online had been useful and attendees supported the ongoing provision of online for the winter meetings.

Request for Scoping Opinion for Proposed Section 37 Application for Kintore to Tealing 400kV overhead line.

SSEN are required to undertake an Environmental Impact Assessment for this project. Basically this will identify and assess negative impact of the development and suggest modification/adaptation to ameliorate such impacts. The Scoping Report will identify what should be considered in the assessment. Both will be made public and submitted to the Scottish Government.

RURAL CRIME

Neighbourhood Watch Scotland's mission:

Safer neighbourhoods, stronger communities..

Neighbourhood Watch Scotland will:

- Collaborate with partners to develop community resilience.
- Grow partner and community use of Neighbourhood Alert and Scotland's Neighbourhood Watch network.
- Enhance a sense of wellbeing by encouraging community cohesion.

What is Neighbourhood Watch Scotland?

Neighbourhood Watch Scotland is a Scottish charity which helps promote safety and resilience in our communities.

It circulates safety messages using the Neighbourhood Alert system (https://www.neighbourhoodwatchscotland.co.uk/sign-up-for-alerts/), which comes from trusted sources keeping the neighbourhood alert.

It currently supports around 1,700 Neighbourhood Watches across Scotland, bringing people together in local and themed groups. This helps communities become safer and more resilient through awareness, advice and communication, sharing key crime and other safety-related news quickly.

What is Neighbourhood Watch?

A Neighbourhood Watch is a community led initiative bringing local people together to address crime and other community safety issues in their area. Watches often liaise with local police and local authorities to raise concerns in their neighbourhood.

There are many benefits to becoming a coordinator or member of your local Watch including:

- Access to the Neighbourhood Alert system which distributes safety information from a trusted source.
- Membership improves community spirit, resilience and a feeling of wellbeing in communities.
- It provides access to Community Policing forums and sources of support.

How can I join my local Watch?

Recent crimes/issues in the Brechin area:

Assessment period - 29.08.24 - 29.09.24

Police dealt with approximately 658 calls within the Montrose, Brechin and Edzell wards area during this period, of which 268 were pertinent to the Brechin, Edzell, and Aberlemno area.

In addition, there were a total of 38 crimes recorded within this time frame, of which 0 were specific to the Aberlemno district area.

The following is a breakdown of crime category in relation to these crimes:

Emerging issues:

Speeding:

There continues to be concerns reported regarding motorists not adhering to the speed limits within the

Local area, in particular 20mph speed zones.

Local Speed Initiatives will continue to be planned where possible and Road Policing Departments have been notified of these continuing issues for extra attention.

Motorists will be warned regarding their use of speed and reported if necessary and further Initiatives will be planned in the future.

In addition, Speed deterrent measures will continue ('Pop up Jim and Jane' signage) to be used.

The following is guidance received from Road Policing Department as regards 20mph Police enforcement,

(as provided by Traffic Scotland Good Practice on enforcement of new 'Safer for People' 20mph zones).

Any further information on 20mph zones or additional safety measures should be referred to Angus Council):

Enforcement

37. Any decision to lower the speed limit to 20 mph should seek to avoid the need

for extensive police enforcement, as 20 mph limits will not be routinely enforced,

unless it is absolutely necessary and in the interest of casualty reduction.

The only exception to this is the enforcement of 20 mph speed limits outside schools, which takes place on a regular basis.

38. A range of other measures should be employed. These might include marketing and behaviour change initiatives,

vehicle actuated signs and traffic management and other traffic calming measures.

39. Any changes should be monitored, and where compliance levels are not at an acceptable level, consideration should be given to the addition of traffic calming measures or reverting to a 30 mph limit, if necessary.










Police Officer Recruitment campaign
