#### **ANGUS ALCOHOL AND DRUG PARTNERSHIP ANNUAL REPORT 2023-2024**

#### **1. ABSTRACT**

The purpose of this report is to seek endorsement from Angus Integration Joint Board on the second Annual Report for the Angus Alcohol and Drug Partnership which provides updates on the business and progression of national policy and priorities in relation to drugs and alcohol at a local level.

#### **2. ALIGNMENT TO THE STRATEGIC PLAN**

This report contributes to the following strategic enablers in AIJB Strategic Commissioning Plan: -

- Prevention and Proactive Care
- Mental Health and Wellbeing and Substance Use Recovery

#### **4. BACKGROUND**

Alcohol and Drug Partnerships (ADPs) are responsible for leading the development and delivery of a local comprehensive and evidence-based strategy to reduce the level of drug and alcohol related harm in their local area. The national [Alcohol and Drug Partnerships: delivery framework](#) places responsibilities on each Local Authority and NHS Board to participate in the ADP and to ensure that other local partners are enabled to contribute appropriately to the delivery of these national strategies and priorities at a local level.

#### **5. CURRENT POSITION**

Angus ADP (AADP) has continued to work and deliver national policy and direction at a local level. Historically, ADPs have provided an annual financial return to Scottish Government. AADP have agreed to the production of an annual report to provide transparency into our activities, progress, and the impact we are striving to achieve.

The annual report provides an overview of both national and local context and highlights progress made by AADP during 2023/24 and highlights the priorities for 2024-2025.

## 6. PROPOSALS

That the IJB recognise the work undertaken, and planned, in regards to the Homeless Supported Accommodation Review and request the Chief Officer bring back a further paper to the IJB detailing the outcome of the review in August 2025.

<b>Planned Risk Level</b>	Likelihood <b>4</b> x Impact <b>2</b> = Risk Scoring <b>8 (Minor risk level)</b>
<b>Approval recommendation</b>	Even with the progression of all agreed actions, this risk remains moderate. Scheduled reporting and monitoring will continue alongside the further development of risk mitigation actions.
