Thought for Golf links submission

- The Natural Landscape - Braes of Angus/Coast – and coastal protection = what are the risk assessments.
- Heating & Energy Networks strategy & response (25/6/24) - why is Carnoustie omitted.
- Whether or not our Community should consider a project via the council that we can on environment = Musical Society, Theatre Club, British Legion, Mens Shed. Forms a complex project – need a way of putting forms and applying for funding.

Flood management

Burn floods – view = do we need Scottish Water & SEPA to discuss? = monitor damage over winter.
New housing at Pitskelly – near roundabout – accepted, and our objections have been only partially addressed. Small developments in piecemeal and no contributions to council, schools. A Local Place Plan can overcome this – over size and scale.

Also issues about 2 burns and risk to golf Course and houses the other side of the railway.

Golf Course = Consultations for Golf course have started and some have attended. Clear and protects interests.

Need to know areas and properties being transferred to Golf Links management from Angus Council and other areas.

Need all areas to be put into writing.

Areas to be concerned for Community Council response = Sale of the assets - £5m (Mike Wells – press quote), constitution, CBF/T? What is meant by environmental protection? Who is the investment trust – now and in the future? Golf only? Who runs it? What land is being transferred? What are leased? What are sold? = look now where the signs are – who owns what land? Phase 1? Who is responsible for Golf land/beach – environmental damage? Helicopter landings?

Action: read response by JD following last meeting sent to individuals via email. John Davidson to write to SEPA, & councillors over Heating & Energy Networks. Future thoughts: A Local Place Plan can overcome this – over size and scale.
